The candidates appearing in the Common Law Admission Test (CLAT) – 2020 and who are interested in seeking admission under the J&K Residents/North East India (NEI) Category for UG (LL.B.) & PG (LL.M) Programmes, subject to satisfying eligibility conditions, can apply directly by sending expression of interest by filling the ‘Admission (Expression of Interest) Form’ on or before 01st July, 2020. The hard copy of the filled-in admission (Expression of Interest) form along with all the relevant certificates shall reach the University through post latest by 15th July, 2020.
