The seat(s) under the North East India (NEI) Category shall be filled by the University directly from the merit list of the Common Law Admission Test (CLAT) – 2022. The candidates seeking admission under any of the above-mentioned categories can apply directly to the University.

1. Number of Seat(s):

PG Programme (LL.M.) –NEI: 01

2. Eligibility:

- A candidate seeking admission under the NEI category shall have appeared in the Common Law Admission Test (CLAT).
- A candidate seeking admission under NEI category shall have to produce a relevant domicile certificate issued by the competent authority at the time of admission.

3. Application Form and Fees:

The candidates interested in seeking admission under the subject to satisfying eligibility conditions can apply directly by filling out the below application form latest by **30th July 2022 (12.00 PM)**.

Step 9: Click on submit button to pay the online payment of application fees.

Step 10: On successful payment, a confirmation e-mail will be delivered to the given e-mail id.

5. Selection Process:

The selection of candidates shall be purely based on merit, out of the application(s) received by the GNLU under this category.

6. General Instructions:

- The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission.
 - The students who have passed their qualifying examination from schools located outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) are required to produce the equivalency certificate from the Association of Indian University. The same certificate is required to produce at the time of admission.  - The candidate(s) applying under PG Programme are required to submit their final year mark sheet of LL. B. Programme at the time of admission.
