**Inviting Expression of Interest for seeking Admission under the Non-Resident Indian (NRI) for PG (LL.M.) Programme for the Academic Year 2022-23.**

Date: 03 August 2022

Gujarat National Law University invites applications for admission under the Non-Resident Indian (NRI) category for PG (LL.M.) Programmes for the Academic Year 2022-23. The seats under the NRI Category shall be filled by the University directly from the merit list of the Common Law Admission Test (CLAT) – 2022. The candidates appearing in the Common Law Admission Test (CLAT) – 2022 and who are interested in seeking admission under the NRI Category for PG Programmes, subject to satisfying eligibility conditions, can apply directly to the University.

**1. No. of Seats: PG – 01**

**2. Eligibility:**

a) A candidate seeking admission under the NRI category shall have to fulfil any one of the below-mentioned conditions:-

i. At least one of the parents of such candidates shall be a Non-Resident Indian and shall ordinarily be residing abroad as a Non-Resident Indian;

OR

ii. The person who sponsors the candidate for admission shall be in the first-degree relation with the candidate and shall be ordinarily residing abroad as a Non-Resident Indian;

OR

iii. If the candidate has no parents or no near relatives or has not been taken as a ward by some other nearest relative, such candidates may also be considered for admission under the NRI category, provided that the guardian has bonafidely treated the candidate as a ward and shall be able to file an affidavit indicating the interest shown in the educational affairs of the candidate and his/her relationship with the candidate. Further, such person (guardians) shall be a Non Resident Indian and ordinarily residing abroad as a Non Resident Indian;

OR

iv. The Person of Indian Origin (PIO) and Overseas Citizens of India (OCI) card holders are also eligible for admission under the NRI seats available at GNLU.

### 3. Application Form and Fees:

The candidates, who are interested in seeking admission under the NRI Category for PG Programmes, subject to satisfying eligibility conditions, can apply directly by filling out the below application form latest by **06 August 2022 (12.00 AM Midnight)**.

### 5. General Instructions:

- i. The candidates appearing in the qualifying examination shall be required to produce evidence of their passing the qualifying examination at the time of admission.
- ii. The students who have passed their qualifying examination from schools located outside India (affiliation boards other than CBSE, ISCE, IB and Cambridge) are required to produce the equivalency certificate from the Association of Indian University. - iii. The candidate(s) applying under PG Programme are required to submit his/her final year mark sheet of LL. B. Programme at the time of admission.

6. The Candidates seeking admission under this category are required to submit the enlisted documents at the time of admission. The candidates may download the same from the GNLU website, and are required to furnish the same at the time of securing the admission.
