(iii) Working experience in MS Office, basic knowledge of information technology; (iv) Strong analytical skills, excellent English writing and communication abilities, and the ability to manage research projects; (v) Working knowledge of Gujarati; (vi) Excellent research and writing skills; <b>Highly desirable:</b> (i) Experience in empirical legal research.
