1. MINIMUM ELIGIBILITY CRITERIA:

The candidate must possess the minimum qualifications prescribed under the **applicable University Grants Commission (UGC) Regulations**, as amended from time to time, and the applicable rules, statutes and ordinances of the University.

The minimum eligibility shall ordinarily be:

A.

1. A **Master's Degree in Law (LL.M. or equivalent)** with at least **55% marks** (or an equivalent grade in a point scale wherever the grading system is followed) in a relevant/concerned/allied subject from an Indian University, or an equivalent degree from an accredited foreign University; and
2. The candidate must have qualified **National Eligibility Test (NET)** conducted by the UGC/CSIR, or an equivalent test accredited by the UGC, such as **SLET/SET**, wherever applicable.

3. Candidates possessing a **Ph.D. degree** shall be considered for exemption from NET/SLET/SET **only to the extent and subject to the conditions prescribed under the applicable UGC Regulations and amendments thereto.**

Candidates possessing a **Ph.D. degree from a foreign University/Institution** shall be eligible subject to the applicable UGC Regulations and other applicable rules of the University, including the requirements concerning recognition/ranking of the foreign University/Institution, wherever applicable.

Important Note on Eligibility

The eligibility of a candidate shall be determined with reference to the **UGC Regulations in force on the date of engagement**, together with the applicable GNLU rules, statutes, ordinances and other governing provisions.

Candidates are required to satisfy themselves regarding their eligibility before appearing for the Walk-in-Interview.

The UGC's consolidated regulations specifically identify **Law** among the disciplines covered by the Assistant Professor qualifications and prescribe the Master's-level 55% requirement and the applicable NET/SLET/SET provisions.

2. TERMS AND CONDITIONS

1. The Walk-in-Interview shall be held on **Wednesday, 12 August 2026 from 11:00 A.M. onwards** at the GNLU Silvassa Campus.
2. **Reporting Time:** Candidates must report at the venue by **10:30 A.M.** Candidates reporting after the prescribed reporting time may not be permitted to participate in the selection process.

3. Candidates must bring:
 - **Four copies of their updated Resume/Curriculum Vitae**, with recent passport-size photographs affixed on each copy;
 - Original certificates/documents relating to educational qualifications;
 - One complete set of self-attested photocopies of all educational certificates/mark sheets;
 - NET/SLET/SET certificate, wherever applicable;
 - Ph.D. certificate and relevant supporting documents, wherever applicable;
 - Experience certificates, if any;
 - Research publications and other academic/research credentials, if any; and
 - Any other document relevant to establishing eligibility.
4. Candidates must produce the **original documents for verification** at the time of the Walk-in-Interview.
5. The selected candidate shall be required to work at:

6. The engagement shall be purely on a **Guest Faculty/temporary basis** and shall not confer any right or claim for regular appointment, continuation or absorption in the University.
7. The selected candidate shall be paid an honorarium of **₹1,500/- per lecture**, subject to a maximum of **₹50,000/- per month**, subject to applicable University rules.
8. The engagement shall be subject to the teaching requirements of the University and shall be for such period as may be determined by the University.
9. The **medium of instruction shall be English**.
10. Selection shall be made on the basis of the candidate's **overall academic/research record, relevant experience and performance in the Walk-in-Interview**, subject to fulfilment of the prescribed eligibility criteria.
11. The University reserves the right to:
 - Not fill the advertised position;
 - Increase or decrease the number of positions;
 - Modify, withdraw or cancel the advertisement;
 - Reject any candidature which does not fulfil the prescribed eligibility requirements.
13. No **TA/DA** shall be paid for attending the Walk-in-Interview or participating in the selection process.
14. Candidates shall be responsible for ensuring that they fulfil all eligibility conditions before appearing for the Walk-in-Interview. Mere appearance in the interview shall not confer any right to selection or engagement.
15. Any attempt to influence the selection process or **canvassing in any form shall result in disqualification**.
16. The selected candidate shall be required to join on the date specified by the University. In case the selected candidate fails to join on the prescribed date, the University may cancel the offer of engagement.
