- (vi) Conduct research based training and extension activities in the area of law;
- (vii) Perform any other duties including administrative, coordination, etc. as required to achieve the aims and objectives of the University.

- (i) Master's Degree in Law with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from an Indian University, or an equivalent degree from an accredited foreign university;

- (ii) Good knowledge of latest national and international research trends and developments in Law;
- (iii) Ability to conceptualize and organize international training workshops and brainstorming online/on-site discussions apart from teaching/Research;

- (v) Experience in teaching/research in premier law universities/colleges.
- (vi) National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET;
