NOTIFICATION

PROMOTION OF TEACHERS UNDER CAREER ADVANCEMENT SCHEME

As per the decision and approval of the 43rd Executive Council meeting in its vide additional agenda Item No.D to follow UGC Regulations for the matters concerning promotions for faculty members of the GNLU, the University is hereby inviting Applications from eligible teachers for the promotions under Career Advancement Scheme (CAS) as per the University Grants Commission (Minimum Qualification for Appointment of Teachers and other Academic Staff in Colleges and other Measures for the Maintenance of Teachers Standard in Higher Education) Regulations, 2010 (No.F.3-1/2009 dated 30th June 2010) and subsequent amendments made in the year, 2013 & 2016 and the University Grants Commission (Minimum Qualification for Appointment of Teachers and other Academic Staff in Colleges and other Measures for the Maintenance of Teachers Standard in Higher Education) Regulations, 2018 (No.F.1-2/2017/(EC/PS) dated 18th July 2018) as applicable.

Submission of Application and Other Information:

1. The teachers shall offer themselves for assessment for promotion by submitting an application. In case, where CAS is pending for multiple stage of promotion, the teachers are required to submit separate applications for each stage of CAS. After scrutinising the application for lower stage, application for higher stage shall be considered, provided that the candidate has to fulfil the conditions as laid down under the appropriate applicable regulations.
2. The teachers may exercise appropriate options with regard to the applicability of UGC Regulations of 2018 or the previously notified UGC Regulations and fill-up relevant application form (kindly refer the table below) accordingly.
3. The teacher shall be on the role and in active service of the University on the date of consideration by Screening-Cum-Evaluation Committee for Promotion under the CAS.
4. The teachers are informed to ensure that all the prescribed conditions are fulfilled before the submission of the application. The relevant documents to the promotion period shall only be attached along with the application forms. In case, if the teacher is submitting more than one application form for different stages, the relevant documents for the particular stage shall be attached in each form.
5. Each stage of promotion shall be regulated as per the applicable UGC regulations.

6. The teachers are required to submit the relevant application form as applicable to their promotion and following table is the guiding factor:-
