Director's Message

The Winter semester continued under the COVID-19 cloud. Consequently, the teaching and evaluation primarily remained online. Except for this, it was a great semester!

We organised three international conferences: Legislative and Regulatory Challenges for MSMEs in collaboration with UNCITRAL RCAP; Law, Economics and Public Policy; and Aviation Law amid COVID-19.

We conducted four training programmes for the Indian armed forces: two residential programmes for Indian Naval officers on the law of the sea and maritime law and two for the Indian Air Force officers, one on Space Law and the other on Arbitration Law for Government Contracts.

We entered into four new collaborations: M. S. Swaminathan Research Foundation, PRAYAS Juvenile Aid Centre, Indian Institute of Public Health Gandhinagar (IIPHG) and Cognizant. We will soon work with PRAYAS to implement the basic child protection laws. At the same time, the IIPHG MoU will allow GNLU faculty an opportunity to aid policy formulation in public health.

To cultivate a culture supportive of mental health and emotional well-being, we launched the GNLU Wellness Initiative Cell. Now, GNLU community members can access professional help for mental health concerns from India's largest online mental health platform, YourDost, round-the-clock with privacy, confidentiality and anonymity. This facility is in addition to the existing in-person, on-campus counselling facility.

Our students and alums continued to shine in diverse fields.

Students of the 2018-23 batch achieved a new milestone by bagging 29 Pre-placement offers a month ahead of Day Zero, the highest ever in GNLU's history and, perhaps, across all National Law Universities this year.

On the mooting front, our students won many accolades at the prestigious Philip C. Jessup International Moot Court Competition. At the same time, another team emerged winners at the fifth Chamber of Tax Consultants National Moot Court Competition.

Our alum, Tejas (2015-20), became a Cambridge Nehru Scholar to pursue his PhD at Cambridge, while Akash (2012-17) won the Squire Patton Boggs Research Excellence Award. He earned a scholarship to pursue the Transnational Arbitration and Dispute Settlement LLM programme at Sciences Po, a research grant for working on the Climate Change Arbitration Monitor, and an internship with Squire Patton Boggs, one of the world's top 30 international arbitration practices.

Yet another alum, Sangeeta Moga (2013-18) cleared the Madhya Pradesh Civil Judge Examination.

But, our students and alums are not all about law.

In sports, the second-year student, Radhapriya, won a bronze medal in the Girls' Singles event at the SBI Khelo India Youth Games. She also represented India at the World Table Tennis Youth Contender held in Tunisia and emerged in the top 8 as

Quarterfinalist.



Shalini (UG 2011-16 and LLM 2019-20) joined the fully-funded Master of Fine Arts (MFA) in Creative Writing programme at Iowa State University, USA.

Another alum, Hatim, the only Indian to receive both the Rhodes and Schwarzman scholarships, is all set to revolutionalise the banking landscape in distressed economies through a Swiss fintech, Masref, co-founded by him.

Yet another alum, Saurav Jhunjhunwala (LLM 2020), took a plunge into active politics and became the youngest councillor in the history of Guwahati Municipal Corporation.

These achievements of our students and alums in diverse fields demonstrate that we not only prepare our students for a career in law but provide a complete ecosystem for their holistic development. We are proud of our student and alum achievers, some of whom the cover page highlights.



GNLU launched the GNLU Wellness Initiative Cell (GWIC), a student-led initiative to create a sustainable, holistic culture of overall wellness for the GNLU community: students, faculty and staff.

At the launch function, Dr Pratima Murthy, Director, National Institute of Mental Health and Neurosciences (NIMHANS), said that some people are more vulnerable to mental health issues than others for various reasons. We should have institutional mechanisms to provide timely help to such people. We should also strive to reduce the stigma associated with mental disorders to ensure that people seek help and treatment early rather than hiding their mental issues.

Mr Arjun Kapoor, Research Fellow at the Centre for Mental Health Law & Policy, ILS, Pune, said academic institutions should create a culture of care and concern, where students can express their concerns and seek expert guidance without stigma.

Dr Jini Gopinath, Chief Psychology Officer of Your Dost, said that our goal should be to prevent mental health disorders. We can achieve this by providing timely help. Therefore, *YourDost* delivers round the clock online

support.

Dr Itisha Nagar, Assistant Professor, Delhi University, said one positive outcome of the Covid-19 pandemic is bringing mental health issues to mainstream discussion. Earlier, we tended sweeping mental health issues under the carpet. But the fear and anxiety caused by the pandemic have brought mental health issues to the fore.

NIMHANS Psychiatry Professor, Prof Geetha Desai, said I am happy that GWIC is a student-led initiative because user-led initiatives have always sustained for a long time.

In his welcome address, GNLU Director, Prof (Dr) S. Shanthakumar, said it is crucial to cultivate a culture supportive of mental health and emotional well-being and a safe space within the university campus.

After the launch event, *YourDost* unveiled its services for the GNLU community (Students, faculty and staff). *Your DOST* is India's first and the largest online mental health and emotional wellness platform.

Apart from the online counselling services, an in-house university counsellor is also available on the GNLU campus for in-person counselling.

PhD Awards

Two doctoral scholars awarded a PhD



Mr Waseem Ahmad Bhat was awarded a PhD for his doctoral thesis "An Analytical Appraisal of the Executive, Legislative and Judicial Powers and Functions of the President under the Indian Constitution" under the guidance of Dr Ravindra Kumar Singh, Associate Professor of Law at GNLU.

The primary area of his research pertains to articles 53, 55, 58, 72, 73, 74, 75, 123 and other ancillary provisions of the Constitution of India. His reformative suggestions include the creation of a Pardon Board for the expeditious and efficient disposal of mercy petitions and a small council to advise the President on behalf of Parliament in the exercise of his ordinance making powers.

Mr Waseem Bhat holds an LLB from the University of Kashmir and an LLM from GNLU. He is currently Assistant Professor of Law at Gujarat Maritime University (School of Maritime Law, Policy & Administration), Gandhinagar.

Mr Ankit Rameshchandra Shah was awarded a PhD for his doctoral thesis "Impact of E-Commerce on Offline Trade: A Study in the Light of Indian Competition and Consumer Protection Law Regime" under the guidance of Dr Viral Pandya, Associate Professor of Management at GNLU.



His doctoral research focused on

the impact of e-commerce on offline trade, measuring change in consumer behaviour due to e-commerce and awareness and effectiveness perspective of competition & consumer protection law regime.

He currently functions as a Consultant in Management, International Business, E-commerce Growth-Modelling, Project management, Instructional design and Curriculum R&D. New Collaborations



M S Swaminathan Research Foundation Science for Sustainable Development





M S Swaminathan Research Foundation (MSSRF) Executive Director Dr G. N. Hariharan and GNLU Director Prof. (Dr) S. Shanthakumar signed an MoU to promote collaboration in research and policy-making in the following areas: Law, Coastal Systems Research, Climate Change, Biodiversity, Biotechnology, Food Security, Education & Communication, and Gender.

MSSRF aims to accelerate the use of modern science and technology for agricultural and rural development to improve the lives and livelihoods of communities. It has impacted lives of over 600,000 farm families, impacting the livelihood of 100,000 farmers and fisherfolk every day with an influence that spreads across 18 countries.

GNLU Director Prof (Dr) S. Shanthakumar said GNLU aims to utilise the MSSRF expertise through joint research projects to resolve the issues of small farmers and people in the coastal areas of Gujarat.





GNLU signed an MoU with Cognizant Technology Solutions India for mutual collaboration.

Cognizant Senior Vice President & General Counsel India & Asia Pacific Mr Narayanan T said it is perhaps the first time in India that a law school has collaborated with a tech giant to create a mechanism that enables industry experts to leverage their expertise and be part of law school projects.

GNLU Director Prof (Dr) S. Shanthakumar said that GNLU will organise retreat and refresher courses for the Cognizant legal team. Cognizant will train and prepare GNLU students to be hands-on in the corporate world, specifically in the Tech Industry. We shortly plan to offer a capsule course on Privacy Issues the IT industry is grappling with, which will be taught jointly by Cognizant experts and GNLU faculty.

Thus, both GNLU and Cognizant will benefit from this collaboration.



Prayas Juvenile Aid Centre (PRAYAS) and GNLU entered into an MoU for collaboration to further common objectives.

Prayas General Secretary Mr Amod Kanth said that, under the "Access to Justice Project" launched by Prayas with the support of Kailash Satyarthi Children Foundation, Prayas and GNLU would soon undertake an intensive exercise to implement the basic child protection Laws like the Juvenile Justice Act, POCSO, child labour and trafficking.

GNLU Director, Prof Dr S. Shanthakumar, said today's MoU will formalise and strengthen our long-standing relationship with Prayas and enable GNLU faculty and students to contribute to the betterment of children in the country, particularly in Gujarat.





GNLU Director Prof (Dr) S. Shanthakumar and Indian Institute of Public Health Gandhinagar (IIPHG) Director Dr Dileep Mavlankar signed an MoU for training and capacity building and to conduct evidence-based policy research to aid policy formulation and monitoring.

IIPHG Director Dr Dileep Mavlankar said, "This Mou will build a partnership to work on health-related laws and their applications. First, we intend to work on a model epidemic act to replace the British era Act, The Epidemic Diseases Act, 1897. We will also work on the legal framework for universal health coverage in India."

GNLU Director Dr Shanthakumar observed, "Many inadequacies of the colonial act have surfaced during the Covid pandemic. Therefore, the Government had to resort to the Disaster Management Act of 2005. Learning from the pandemic, we need to have a proper legal framework to deal with the public health challenges posed by epidemic diseases. We look forward to working with IIPHG in this area, among others, to aid policy formulation in public health."

GNLU Hosts a Fulbright Specialist



GNLU hosted its first Fulbright Specialist in Dr Brian Wilson from 01 to 30 June 2022. GNLU Times interviewed Dr Wilson for you. Here are the excerpts:

GT: Please tell our readers about yourself.

BW: I am an attorney in the U.S. Coast Guard and have been a visiting professor of law for over a decade. In my current position, I support collaborative efforts that integrate agencies in response to maritime threats that range from piracy and drug trafficking to illegal fishing and malicious cyber activities. I previously served in the U.S. Navy in their JAG Corps, with assignments that included serving on an aircraft carrier to postings in Japan and Antarctica as well as the Pentagon, retiring in the rank of Captain.

GT: Why did you choose GNLU for your Fulbright Specialist programme?

I had the pleasure of visiting GNLU five years ago as part of a multinational team of professors and officials led by the U.S. Naval War College's Stockton Center for International Law (SCIL) to teach and develop a curriculum at GNLU for the Maritime Law Academy. GNLU is more than a highly rated law school. To me, it is a unique nurturing community. I either learned something new or met someone new in every class or meal. As GNLU has previously and continues to prioritize maritime security and the law of the sea in focused programs with subject matter experts from across the globe, it was thrilling to have the opportunity to return to such a wonderful community.

GT: Can you tell us about your professional engagement at GNLU during your stay here?

I supported the GNLU courses on the law of the sea and maritime law for Indian naval officers. These innovative courses provided essential building blocks for advancing maritime law and the law of the sea by focusing on the extensive body of laws involving naval operations, as well as areas in which there is a lack of clarity.

I delivered presentations on piracy, countering maritime terrorist acts, international legal authorities, and collaboration (including whole-of-government, bilateral, and multilateral efforts). We also discussed the use of force standards, flag state authorities, crisis management, countering drug trafficking, port security, and the maritime impact of United Nations Security Council Resolutions.

Other areas included cyber warfare, unmanned systems, aviation authorities, and evolving areas in maritime enforcement. Our discussions also examined the intersection of the law, policy, and naval actions. This emphasis enabled impactful discussions on how the law can both support and advance operations.

One of my favourite discussions included mishandled responses to maritime challenges and the lessons they can provide. By studying mishandled responses in the maritime space, we gained insight into decision-making, leadership, coordination frameworks, and risk management. Another discussion included an examination of checklists for maritime response efforts: where they can be beneficial, what substantive response areas can be improved with their use, and whether there are any limitations. And yet another instructive area in our class included an assignment to draft an informational memorandum on an emergent maritime issue and a group assignment to document risk considerations and options for a commercial shipping firm transiting in high-risk waters.

GT: Can you tell us something more about these programmes?

The maritime environment comprises unique elements that don't exist on land: flag state concepts, exclusive flag state jurisdiction, maritime zones, among others. Moreover, media coverage highlights threats, conflicts, and challenges unfolding daily in the maritime space. These two factors underscore the tremendous benefits of the courses Prof Dr Shanthakumar and Ms Harsha Rajwanshi brilliantly designed. These courses ensured extensive coverage of various topics unmatched in India to enhance awareness of crucial policy issues and legal considerations in the maritime environment. Graduates of these programs are better positioned to address maritime security issues in their current (and future) positions.

GT: How was your experience at GNLU? How will it add value to your work back home?

My experience at GNLU was exceptionally valuable in advancing the rule of law in the oceans. I cannot recall another engagement where the students were as interactive or effective in fostering a collaborative learning environment. The vibrance in each class was a direct result of the willingness of the students to challenge assumptions and question assertions. The experience of the Indian naval officers also contributed to robust discussions, and the course architect, Prof Dr Shanthakumar and Ms Rajwanshi, skillfully designed classes that build upon one another, complementing (but not repeating) earlier discussions. My experience at GNLU will help shape how I approach future educational and collaborative engagements. I am also bringing these lessons learned to other teaching I have been involved in, including engagements with SCIL and the IMO International Maritime Law Institute. The programs for both courses ensured that learning objectives were met, professional awareness was improved, and students were better prepared to confront complex legal challenges. GNLU's focus on program development, interactive discussions, and course implementation will add value to my work.

Training Programmes for Indian Naval Officers





GNLU conducted two residential training programmes on the law of the sea and maritime law (including naval Ops) for the Indian naval officers: a long-duration course from 21 March-17 June 2022 and a short-duration course from 09 May-10 June 2022.

Six naval officers attended the long-duration course. Fortythree eminent academicians, researchers, practitioners and consultants worldwide delivered 183 teaching sessions spread over 61 teaching days, covering 21 modules on the law of the sea, naval operations, and maritime law. Indian Navy nominated 20 officers to attend the short-duration course. Twenty-four eminent resource persons from across the globe delivered 98 teaching sessions over 26 days.

Professors from the U.S. Naval War College's Stockton Center for International Law also delivered lectures in these courses.

Commodore Sanjay Nagar, Director, MWC, Kochi, said the participating naval officers benefited from their interaction with many domain experts from across the globe. "Based on the feedback these officers gave, I am happy to convey that the experience was truly exhilarating," he added.

Ms Harsha Rajwanshi, Assistant Professor of Law, coordinated these courses under GNLU Director Prof (Dr) S. Shanthakumar.

On Day 2, workshop on 'Game Theory and Systems Thinking for Global Commons' delved into


the problem of collective action through a game theoretical lens.



Book Launch Function in the loving memory of the late Dr Aruna Kumar Malik



GNLU organised a function to launch a book titled "Advancing Environmental Justice for Marginalised Communities in India: Progress, Challenges and Opportunities" on 21 April 2022.

The book is edited by a GNLU faculty, Dr Aruna Kumar Malik, jointly with University of Winnipeg faculty Alan Diduck and Kirit Patel, and published by Routledge.

Dr Aruna Kumar Malik, an Assistant Professor of Political Science at GNLU, succumbed to Covid-19 on 28 April 2021. 

Festina Affair: Rise of World Anti-Doping Agency

Mr Tarun, Assistant Professor (Research), gave a seminar on "Festina Affair: Rise of World Anti-Doping Agency".

Mr Tarun narrated how the doping scandal in the elite sporting event "Tour de France", one of the biggest doping scandals in the world of sports, led to establishment of the World Anti-Doping Agency (WADA). He also discussed some important articles of the World Anti-Doping Code that harmonises anti-doping policies, rules and regulations within sports organisations and public authorities worldwide.

The code, adopted worldwide by more than 600 sports organisations and the majority of national governments worldwide laid the foundation for closer cooperation between governments and sports organisations on the doping problem. Thus, it is one of history's most successful examples of international cooperation.

Workshop on Research Methodology

GNLU conducted the ten-day workshop on Research Methodology, sponsored by the Indian Council of Social Science Research (ICSSR), from 19 to 28 February.

In his introductory remarks, GNLU Director Prof (Dr) S. Shanthakumar commented on the dismal state of research in India, stating that questions have been raised on the quality and authenticity of the research output of Indian institutions. He said India must focus on the quality of research.

Dr Shanthakumar further highlighted that India has only 216 researchers per million population while the USA and France have about 4,300 researchers per million population. India spends only 0.62% of its GDP on research, way below the USA (2.74% of GDP) and France (2.25% of GDP).

The Rajiv Gandhi National University of Law, Punjab's Vice-Chancellor Dr G. S. Bajpai, echoed the views

expressed by Dr Shanthakumar and said many times, PhD happens, but research doesn't happen. This state of affairs gives rise to a general perception that India produces third-class PhDs on an assembly line. It, therefore, needs an immediate fix.

Pandit Deendayal Energy University's Director-General Dr Sundar Manoharan reminded the participants that "your research is your duty towards your nation and not towards your promotion." He said that every research must have a social impact. The social impact has to drive your research and be your motivation and the essence of your research. If there is no social impact, it is not affecting your mind, soul and body, then it is only an academic exercise, and the research topic is a mere convenience.

Eminent experts in diverse disciplines from reputed academic institutions engaged the participants on many topics on research methodology.

GNLU Centre for Law and Economics (GCLE) organised the 5th GNLU International Conference on Law, Economics, and Public Policy on 10 & 11 March 2022.

Chief Guest, Justice (Dr)Arjan Kumar Sikri, Former Judge, Supreme Court of India, addressed the conference on "The Role of Judiciary: Law and Economics Perspective." He said judges are not economists, but economic factors arise in almost all laws. Therefore, judges should bear in mind the economic impact of judicial decisions while delivering justice. The judiciary's challenge is to strike a balance between economic efficiency and legal rights.

Guest of honour, Shri Sanjay Prasad, said the discipline of law and economics is not new to India. In fact, Kautilya's Arthashastra running into 15 books and 150 chapters, is a treatise on law and economics. It includes, among others, books on the nature of government, law, civil and criminal court systems, ethics, economics, markets and trade, diplomacy, theories on war, etc.

In his inaugural address, Dr Shanthakumar said the discipline of law and economics is confined mainly to the traditional first-year law school courses of torts, contracts,

property, criminal law, etc. We should expand its scope to address significant problems society faces today, such as poverty and inequality, development, education, health care, energy, and the environment. It would require a deep understanding of these problems' institutional, economic, statutory, and political structures. It may involve less law and more policy. It would also require a somewhat different set of tools than most law and economics scholars currently possess. Therefore, legal experts will have to work with experts in other fields such as economists, social scientists and political scientists.

GCLE Head, Prof (Dr) Ranita Nagar, gave a brief account of the Centre's activities and introduced the Conference. She said that out of 76 papers received for the Conference, 33 werer selected for presentation after a review.

The Conference had four plenary sessions and eight technical sessions, and featured the most renowned scholars in law and economics both within India and overseas.

Prof (Dr) T. S. Somashekar, Professor, National Law School of India University, Bangalore graced the valedictory.

Reading of evidence, and the process of examination and cross-examination in criminal trials: Challenges and grey areas in the practical scenario



Mr Shekhar Naphade, Senior Advocate, Supreme Court of India, delivered the webinar on 16 April

Adv. Shekhar Naphade has an illustrious career. He has been practising in the Supreme Court of India since 2001. He appeared in many famous cases, including Jayalalithaa's disproportionate asset case; Board of

Control for Cricket in India case; Impeachment proceedings for removal of Mr Justice Soumitra Sen, Judge Calcutta High Court; Lalita Kumari Case (interpretation of section 154 CrPC); Hardip Singh v State of Punjab and Ors. (section 319 CrPC); Constitutional challenge to the Maharashtra Control of Organised Crime Act 1999; Aruna Shanbaug's case (Passive euthanasia); and Bar Dancers' Case.

He discussed the law of evidence concerning criminal trials in the Indian context. He stated that the law of evidence has three important aspects: roots in substantive law, relevant facts, and assessment of the evidence. He discussed the intricacies involved in the assessment of evidence, the examination and cross-examination of a witness, types of questions during the examination, witnesses turning hostile and limitations of cross-examination. He also briefly touched upon the dying declaration and its legal standing in the Indian Evidence Act.

He took questions on many topics, including narco-analysis tests, court oaths, deposition of false evidence, etc.

He advised budding lawyers: Master the facts of the case, master the techniques of applying relevant laws to the case, ponder the matter in-depth and have professional integrity.

GCRCJS Head, Dr Anjani Singh Tomar, thanked Mr Naphade for his insightful lecture.

Centre for Law and Technology Artificial Intelligence intersecting the ambit of Intellectual Property Laws

Ms Gopi Trivedi, Senior Partner, Y.J. Trivedi & Co., delivered the webinar.

She said Artificial Intelligence (AI) is progressing rapidly and AI-based products and processes will become part and parcel of your daily life sooner than you can imagine. Love it or hate it, but you can't ignore it!

With the rapid advancement of AI, several questions have arisen concerning Intellectual Property Laws:

- If AI today makes an original work or innovates a 1. product, can these works be protected by intellectual property laws such as copyright and patent?
- If so, who will get the IP rights the AI-based 2. machine or the machine's creator?
- Can AI be considered a legal entity? 3.
- Whether AI-generated designs granted design 4. protection?

- Are the existing IP laws sufficient to safeguard the works / innovations produced by AI?
- 6. Who shall be accountable if AI infringes a third party's IP rights?

There is considerable ambiguity on these and similar questions as courts in the UK, the USA, Europe, China, Japan Ms Gopi Trivedi and Australia have taken different



positions. Therefore, there is a need for a specific law to deal with data protection regarding AI software covering all the civil and criminal liabilities and offences.

GCLT Head Prof (Dr) Thomas Mathew proposed a vote of thanks.

Stakeholders Consultation on Child Rights: Ensuring Access to Justice For Children



GNLU Centre for Law and Society (GCLS) organised a Stakeholders Consultation on *Child Rights, Ensuring Access to Justice For Children*, in collaboration with Prayas Juvenile Aid Centre Society (Prayas).

Diverse stakeholders from the State police department, State labour department, District Legal Service Authority, Child Welfare Committee, City Childline, Ahmedabad Railway Childline, UNICEF, Bachpan Bachao Aandolan and PRAYAS participated in the consultation.

Prayas General Secretary, Mr Amod Kanth, said we have laws to protect children from sexual offences, child labour and human trafficking. However, there are massive gaps between the laws, policies, and services reaching the children in need. We look forward to working with GNLU to improve these laws' implementation and expand our reach to the children in distress.

GNLU Director Prof (Dr) S. Shanthakumar discussed the issues related to reporting, case trial, pendency, disposal

and rehabilitation of the victims of child sexual abuse.

ADGP, CID Crime, Mr Anil Pratham, IPS, suggested that regular coordination between NGOs and government authorities can help improve the implementation of legal provisions. He also stressed the need to enlighten people about child rights as public perception is crucial.

Assistant Commissioner of Police, Mahila Cell, Ms Mini Joseph, criticised society's double standards and said we raise our children to be scared and fearful of the police and then ask them to talk to the police fearlessly in case of any abuse!

Ahmedabad District Legal Service Authority's Secretary, Mr Hiren Vasavda, expressed concern over victim disposition and inability of child victim to contact support person at right time.

Peace of Equality Director Ms Preeta Jha discussed her field experience working with the victims under the POCSO Act.

Women Entrepreneurship

Women entrepreneurs Ms Monica Das (Founder of Respire Experiential Learning) and Ms Niyati Mehta (Founder and CEO of #Be The Change) participated in the panel discussion on Women Entrepreneurship. They shared their entrepreneurial journey and leadership lessons from the same.


She argued that the changing international strategic landscape opens up new opportunities for these "natural partners" to seek a deeper dialogue in a period of strategic confusion and increased great-power rivalry. Despite different geographical and geopolitical priorities, there remains ample scope for India and the EU to learn from each other's experiences of managing diversity, enhance engagement and synergise their visions for an international order. Both can work together to set a normative context for discussion and negotiation on key issues related to global governance such as terrorism, climate change, biodiversity protection, connectivity, health resilience and promoting an inclusive multilateral cooperative security architecture in the Indo-Pacific. Europe can look up to India to craft a meaningful role for itself in engaging beyond the issues of trade and investment in Asia and strengthen cooperation in counterterrorism, maritime security, and nuclear non-proliferation.

The lecture was followed by an engaging Q&A session and concluded with a vote of thanks by GCFPS Head Dr William Nunes.

This lecture was the first in the lecture series started by GCFPS to advance the understanding of foreign policy issues and prevailing national and international security issues.

Society should recognise the needs of the sexual and gender minorities who menstruate. It is essential to bring the conversation around menstruation, considering all menstruating individuals.

We Menstru Act and Kamakhya-The Period Bank founder Ms Twisha Bhatt said many stigmas and stereotypes around menstruation in India need to be removed. She urged girls to bleed with pride as menstrual blood is the only blood that bleeds without violence.

Drawing upon her experience as a cancer researcher in Tata Memorial, Oo Womaniya Co-founder Ms Krutika Katrat focused on health care issues. She believes that by increasing young people's awareness of their own bodies' internal processes, they will be able to overcome the shame, anxiety, and humiliation connected with menstruation, which in turn would lead to better menstrual hygiene and reproductive health.

Vaccination Policy for Persons with Disabilities

GNLU Centre for Disability Studies(GCDS) submitted suggestions to the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India on Vaccination Policy for Persons with Disabilities.

The Government had invited these suggestions from all stakeholders and domain experts in disability under the Supreme Court of India's direction dated 25 January 2022 in the case of Evara Foundation v. Union of India, WP (C) 580/2021.

The suggestions mainly included making the vaccination policy inclusive for PWDs, making vaccine-related information accessible, setting up special and accessible vaccination centres, and introducing the doorstep vaccination system.

Dr K. Parameswaran, Associate Professor of Law, conducted a Self-Help Therapy Workshop on 12 May.



Hatim: Revolutionalising banking landscape in distressed economies




Hatim Hussain (2015-2020) is a founding team member of a Swiss fintech, Masref, that makes Swiss saving accounts accessible to everyone, everywhere. Think countries with high inflation, banks that cap withdrawals, no trust in banks, or no financial services like insurance and investments. By leveraging emerging technologies, Swiss banking infrastructure, and its recent regulatory changes, Masref provides the middle class in these countries with what they never had — a safe place to store their savings. They will begin by offering simple USD savings accounts to everyday people in Lebanon (no or low minimums) before offering other financial services such as third-party transactions, cards, payments, etc.

He is also pursuing doctoral studies at the University of Oxford as a Rhodes scholar.

After graduating from GNLU, Hatim pursued the Schwarzman Scholars programme at Tsinghua University (2021) and read for the Bachelor of Civil Law at the University of Oxford on the Rhodes Scholarship (2022).

Kewal J. Shah (2012-2017) appeared for defendant in the First Appeal No. 2202 of 2021 (Jinnat Fatma Vajirbhai Ami W/O Nishat Alimadbhai Polra) before the High Court of Gujarat. He carried out a detailed research and assisted the Hon'ble Court in making the correct decision. In the landmark judgement, the Hon'ble High Court,

while allowing the appeal and dismissing the Family Suit instituted by the respondent-husband for restitution of conjugal rights, held that a Muslim husband could not compel his wife to cohabit even by decree. He cited the judgments of the Allahabad High Court and Bombay High Court that under Mohammaden Law, marriage is a civil contract and therefore, a suit for restitution of conjugal rights would be deemed a suit for specific performance.




