PROCEDURE FOR MAKING ONLINE PAYMENT

Step1: Select the Academic Fees 2016-17

Step2: Enter Your Registration No

Step3: Based on selection detail will be filled automatically

Step4: Fill the other required detail and click on Proceed To Pay




Step5: Will be redirected to payment gateway, fill the detail and submit it

Step6: Once the payment gateway successfully receives the amount, it will generate the payment receipt

1. The Date of birth & Mobile number entered can be used for generation of duplicate receipt. So, kindly remember the same.
2. Separate instruction will be issued for the payment of fees by students under the NRI category.
3. It shall be the responsibility of the student to ensure that the fees paid shall be for the year in which the student is studying; GNLU shall not be responsible for any mistake of the student in making the payment of fees.
