- > GNLU may conduct Legislative Drafting Workshop.
- ➤ GNLU may think of the possibility of the collaboration with High Court of Gujarat for training purpose.
- The IQAC also suggested to enhance IT facilities in the campus in view of recent IT era.
- The IQAC also suggested to prepare workload data sheet and accordingly, workload distribution system must be developed.
- ➤ It was noted that Account Section and Examination Section have been provided with sufficient Human Resources. If any Department/Section of the University feels that his/her Section requires additional staff/hands, the Section Head supposed to approach the Office of the Registrar/Deputy Registrar.
- ➤ GNLU can adopt a system of central repository of documents.
