### SPECIAL LECTURE SERIES ON UGC- NET AND SET EXAMINATION PART-I HELD ON 18-19TH JULY 2015 AT THE GUJARAT NATIONAL LAW UNIVERSITY, GANDHINAGAR.

#### **Objectives of the Course**

Accurate planning is necessary to achieve success in the UGC- NET examination. There is a need for proper guidance and strategy. It is also necessary to have a clear understanding of the syllabus, trends and the pattern of questions. An in-depth study is required from an authoritative textbook in all these three papers. It is advisable to prepare concise notes for the respective subjects and revise them again and again.

#### **Course Coverage**

This programme will focus exclusively on the following subjects i.e. Constitution of India, Legal Theory and Jurisprudence (Paper II and III). Special emphasis will be laid on previous years question pattern, current cases / issues on the concerned topic.

#### **Objective of the Course**

Accurate planning is necessary to achieve success in the UGC- NET examination. There is a need for proper guidance and strategy. It is also necessary to have a clear understanding of the syllabus, trends and the pattern of questions. An in-depth study is required from an authoritative textbook in all these three papers. It is advisable to prepare concise notes for the respective subjects and revise them again and again.

#### **Course Coverage**

#### 1) Law of Contracts- General Principles:

Essential of valid Contract, Offer, acceptance and Consideration, Capacity to Contract –Minor's Contract, Elements of vitiating contract – mistake, fraud, misrepresentation, public policy, coercion, undue influence, frustration of contract, Remedies for breach of Contract – Damages.

#### 2) Law of Torts:

Foundation of Tortuous Liability, General Defences to an action of Tort, Vicarious Liability, Remoteness of Damages, Contributory Negligence, Absolute and Strict Liability. Nature and definition of Tort, General Principles of Tortuous Liability, Specific Torts – Negligence, Nuisance and Defamation, Absolute Liability – Emerging trends in India.

#### 3) Law of Crimes- General Principles:

Nature and Definition of Offences, General Exceptions, Common Intention and Common Object, Criminal Attempt, Conspiracy and Abetment. General Principles of Criminal Law – meaning, nature, essential and stages of offence, Joint Liability; Abetment and Criminal Conspiracy, Offences against Human Body, Offences against Property, Defamation.





#### 4) Public International Law:

Nature of International Law and its relationship with Municipal Law, Sources of International Law, Recognition of States and Governments, United Nations, Settlement of International Disputes, Human Rights Concept of sovereignty and its relevance today, Extradition, Asylum, Nationality and Status of Refugees, International Court of Justice, UNO and its organs, Global Trade Regime under International Law.

#### **Resource Persons**



Prof. (Dr.) Bimal N. Patel: Professor Patel serves as the Director and Professor of Public International Law at the Gujarat National Law University. He teaches courses and supervises thesis and seminar papers in Public International Law, Peaceful Settlement of International Disputes and Law of the Sea and Maritime Law at undergraduate and post-graduate level. Professor Patel possesses more than 20 years combined experience of progressively academic leadership and scholarly teaching, research experience in general international law, international relations, law of the sea, maritime law and international organizations.
