ABOUT THE COMPETITION

GCCIL, in collaboration with the Indian Law Association (ILA), presents the 3rd Edition of the GCCIL National Mock – Corporate Insolvency Resolution Process (CIRP) Competition, 2026. The competition is designed to bridge academic learning with practical exposure, offering law students a realistic insight into India's insolvency framework.

Participants will step into the roles of insolvency professionals, resolution professionals, and adjudicating authorities and will be tasked with drafting innovative, legally sound, and commercially viable resolution plans for a distressed corporate debtor. These plans will be presented before a simulated Committee of Creditors and adjudicated by a mock National Company Law Tribunal (NCLT), where creditor voting will determine the outcome of the resolution process.
