Distinguished Lecture Series: Address by His Excellency Ambassador (Retd.) Mr. Rengaraj Viswanathan, Former Ambassador of India to Argentina, Uruguay and Paraguay, 13th July, 2017

GNLU in collaboration with Ministry External Affairs, Government of India organized the Ambassador Lecture Series on 13th July 2017 which was graced by His Excellency Ambassador (Retd.) Mr. Rengaraj Viswanathan, Former Ambassador of India to Argentina, Uruguay and Paraguay. The title of the lecture was 'Latin America and Indian Foreign Policy'. During the lecture, he detailed a unique history of cooperation and trade that India, particularly Gujarat, and Latin America have shared. Beyond the framework of imports and exports, there has also been sharing of culture and values by people such as Harivardhan Shah who set up the Gandhi Peace Foundation to spread Gandhian ideals of non-violence in Medellin. Overall, HE Mr.

Viswanathan emphasised the unrealised potential of soft diplomacy, especially with Latin American countries whose potential as allies have been underestimated due to their geographical distance. He then laid down a brief history of how India and Latin America have benefitted over decades through mutual trade of goods, services and ideas, including yoga and the IT industry which has overcome a traditional barrier of business – distance.



14th Foundation Day, 17th July, 2017

The 14th Foundation Day of Gujarat National Law University was celebrated with great enthusiasm on the 17th July 2017. The Hon'ble Chief Minister of Gujarat, Mr. Vijay Rupani graced the occasion as Chief Guest. The event was also graced by the Hon'ble Chief Justice of Gujarat, Mr. R. Subhash Reddy & Hon'ble Law Minister of Gujarat, Mr. Pradeepsinh Jadeja as distinguished Guests of Honour. Advanced Training Programme on Appreciation of Evidence in Criminal Trial, 4th-6th August, 2017

The course was designed to impart the practical knowledge for appreciation of different forms of evidence in criminal trial. The three days training programme witnessed the deliberations on the knowledge about the concepts and principles underlying the law of evidence, the relevancy and admissibility of different forms of evidence in criminal trial, the skills of appreciation of different forms of evidence, effectiveness of evidence related provisions under the Criminal Laws (Amendment) Act, 2013, analyzed the recommendations of 185th Law Commission of India's Report on review of the Indian Evidence Act, in the light of recent leading judgments. Four Workshops with Integrated Child Development Services (ICDS), Women and Child Development Department, Government of Gujarat

Integrated Child Development Services (ICDS), Women and Child Development Department, Government of Gujarat organised a series of four workshops at Gujarat National Law University. These workshops were mainly organised for Anganwadi workers who are working as the rudimentary workers under the Integrated Child Development Scheme. Anganwadi workers are required to perform various activities as part of implementation and have to bring the prescribed results for the programme. Guidelines have been given by the Government of India to train Anganwadi workers, under it's 16 Anganwadi Workers Training Center are running in the state of Gujarat. Anganwadi workers are usually given jobs and refresher training.



National Seminar on Real Estate Legal Regime: Issues, Challenges and Development, 23rd August, 2017

GNLU through GNLU-CCEL Fellowship on Real Estate Laws, Policies and Practices organized a National Seminar on Real Estate Legal Regime: Issues, Challenges and Development on 23rd August, 2017. The main aim of the seminar was to discourse and deliberate on the contemporary issues related to RERA by the experts in real estate sector. A total of 52 papers were selected for paper presentations at the seminar from students, legal practitioners and academics from various institutions across the country. The seminar witnessed presentations of various contemporary issues like variations in real estate sectors after the Act has been brought into force; transparency and accountability in real estate sector; cashlessness on realty market; benami transactions; real estate investment trust; consumer's protection under the new legal regime; foreign direct investment in real estate and the concept of affordable housing under the new Act.

The GNLU Debate, 25th-27th August, 2017

The 5th edition of The GNLU Debate was successfully organized from 25th-27th August, 2017. This edition was a platform for the interaction of diverse debating cultures from all around the Asian debating circuit. The motion of the Grand Finals was based on John Rawls theory of justice and the veil of ignorance. The team from Symbiosis Law School, Pune emerged as the Champions. Debaters from WBNUJS, Kolkata and MS Ramaiah College, Bangalore were awarded the Best Speaker and Best Adjudicator awards respectively. This edition saw the largest participation with a total number of 149.



Six Training Programmes with Integrated Child Development Services (ICDS), Women and Child Development Department, Government of Gujarat

ICDS, Women & Child Development Department, Government of Gujarat developed the curriculum for the Anganwadis of Gujarat for Early Childhood Care and Education (ECCE) and the supplementary material for its implementation. The Curriculum rollout trainings are completed for 53029 Anganwadi workers in the state in Phase – I ECCE activities.

Now for the effective implementation of ECCE at Anganwadi levels, ECCE Phase – II activities were planned. The training and Workshops on developing the Road Map strategy for the ECD, Workshop on Developing Monitoring & Mentoring tool, Training of Instructors Anganwadi workers training centre, Orientation of the ICDS officials on the Monitoring and mentoring tool and the training of State Level Master Trainers was organized at GNLU.

Certificate Course on International Criminal Law and International Crimes, 4th-11th September, 2017

The University organized a Certificate Course on International Criminal Law and International Crimes, 4th-11th September, 2017 on its campus. Prof. (Dr.) Richard Vogler from the University of Sussex was the resource person for the same. This course aimed to introduce students to the institutions and practices of international criminal law as well as to the nature and extent of the offending which has given rise to these developments. It then looked at other threats to global security and the safety of human beings, including terrorism, drug trafficking, slavery and people trafficking, corruption and financial crime. It also covered contemporary institutions which have been created by the international community in the last few decades, such as the International Criminal Tribunal for the Former Yugoslavia (ICTY) and the International Criminal Court (ICC) as well as international and regional policing agencies such as Interpol and Europol. A total of 25 students participated in the course.

3rd GNLU Moot on Securities and Investment Law, 7th-10th September, 2017

The Moot Court Committee organized the 3rd edition of the GNLU Moot on Securities and Investment Law from 7th-10th September, 2017. The competition boasts of successful collaborations with Finsec Law Advisors, Suvan Law Advisors, Khaitan & Co., Bombay Stock Exchange – Investors' Protection Fund, Manupatra and SCC Online. The Moot Court Competition witnessed participation of 44 teams from various law schools across the country from several states. The team from the West Bengal National University of Juridical Sciences, Kolkata emerged as the winners of GNLUMSIL 2017 and received a trophy along with a cash prize of Rs. 50,000; one year subscription to SCC-Online and books sponsored by Finsec Law Advisors and Suvan Law Advisors. 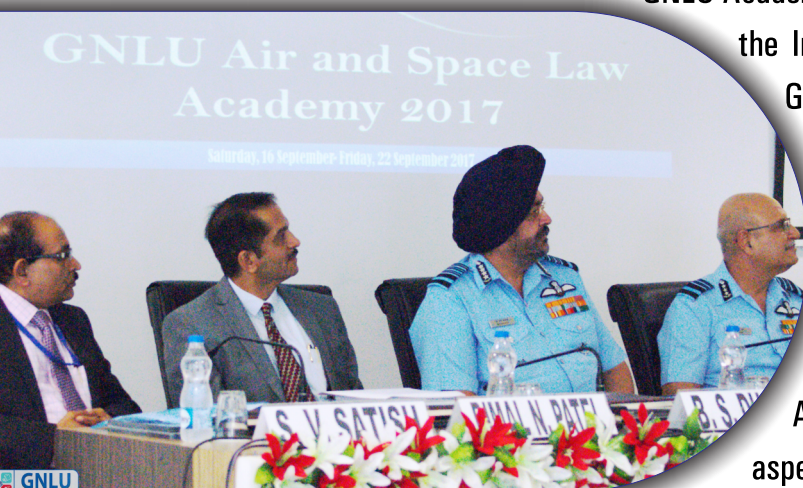


GNLU Academy on Air and Space Law (GASLA), 16th-22nd September, 2017

The Centre for Public International Law, Gujarat National Law University (GNLU) organised the second edition of GNLU Academy on Air and Space Law (GASLA) in collaboration with

the Institute of Air & Space Law, University of Cologne, Germany from 16th to 22nd September 2017. The 2017 Edition also included a two day seminar on the major theme of “50 Years of the Outer Space Treaty”. The Academy was inaugurated by Air Chief Marshal Birender Singh Dhanoa, PVSM, AVSM, YSM, VM, ADC Chief of the Air Staff, Indian Air Force. The Academy aimed to acquaint participants with various aspects relating to safety and security of aviation and space activities; to enhance understanding amongst the participants of

the various principles enshrined in the international instruments meant for regulating air and space law; to create awareness amongst participants about recent trends in civil aviation and the militarization and commercialization of outer space; to enable the participants to understand the various dispute redressal mechanisms in Air and Space Law and their efficacy; to facilitate discourse amongst stakeholders within the industry about practical challenges and the feasibility of implementing regulations and policies in the airspace and outer space; to familiarize participants with country specific approach with regard to air and space law; to enable participants to appreciate the challenges in developing national aviation and space policy. Resource persons from Indian Air Force (IAF), Indian Space Research Organisation (ISRO), Airport Authority of India (AAI), Institute of Air & Space Law, McGill University, North-West University (Potchefstroom Campus), South Africa, Institute of Air and Space Law, University of Cologne, West Bengal National University of Juridical Sciences, Kolkata, India and GNLU engaged academically enriching sessions on various significant and contemporary topics pertaining to Air and Space Law. Participants comprised students, research scholars, officials nominated by IAF, ISRO and AAI.



The GNLU Model United Nations: GNLU SAARC Stakeholder Summit, 23rd September, 2017

The GNLU Model United Nations Society hosted the 1st GNLU SAARC Stakeholder Summit on the 23rd September, 2017, on the theme of “cross border terrorism”. The Summit saw delegates represent various countries with vested interests in SAARC come together to discuss solutions to the problems that plague

SAARC as an organization. The agenda for the one-day simulation was “Reviewing the SAARC Anti-Terrorist Mechanism” and was divided into 4 sessions, with each session focusing on a particular question that was posed to the participants. There were specific issues that this meeting primarily sought to discuss – the establishment of a regional, technically-focused counter-terrorism mechanism; the feasibility of constituting a special court to effectively adjudicate cases of cross-country terrorism; and the impact of this war on terrorism on the civil and human rights of the SAARC countries.



Workshop on Applied Statistics using SPSS tools for Legal Studies, 23rd -24th September 2017

The GNLU Centre for Law and Economics organized a two day Workshop on Applied Statistics using SPSS tools for Legal Studies from 23rd to 24th September, 2017. The aim of the workshop on Applied Statistics was to give the fundamentals of statistical analysis. This course introduced the basics of statistics for researchers to summarize numerical and categorical data obtained from surveys, experiments, etc. The topics included different data types, measures of location, variability, shape, and association between variables. The students were expected to learn the fundamental concepts of estimation, confidence intervals, hypothesis testing and apply appropriate tests for a population mean, proportion, variance and difference, independence and goodness to fit. Dr. Gaurang Rami, Professor, Department of Economics, Veer Narmad South Gujarat University was the distinguished resource person for the workshop.

UGC - GIAN Course, 25th -29th September, 2017

The University organized a course on European and Italian Corporate Law under the UGC-GIAN Course scheme. The course introduced students to the Corporate Law aspects from European law perspective with a specific focus on Italian Corporate Law. The course also helped to understand harmonized areas of company law in Europe and discussed common features of and variation in National Corporate Law practices across Europe. Prof. (Dr.) Matteo Smacchi from the University of Rome was the distinguished resource person for the course.

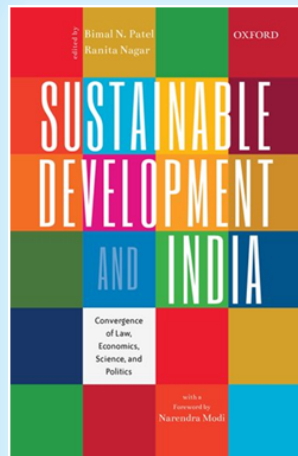
