1. Introduction

The Gujarat National Law University is pleased to announce a Call for Applications under Prof. (Dr.) V.S. Mani Memorial Young Student Travel Subsidy Grant 2019-20sponsored by Prof, (Dr.) Stephen Hobe. MYSTSG supports undergraduate, postgraduate, doctoral students of GNLU with travel subsidies to participate in conferences, workshops, seminars and academies in Air and Space Law held abroad.

2. <u>Objectives</u>

The programme aims to assist students who have a passion for Air and Space Law- The amount of allocated funds for this purpose may vary from year to year.

3. <u>Eligibility</u>

- a. The applicant must be a full-time student (Undergraduate/Postgraduate/Doctoral) of GNLU;
- b. The applicant will be sponsored to participate in International Conferences/ Workshops/ Seminars/ Academies relating to Air and Space Law that are held abroad;
- c. A minimum of 90% class attendance in the previous academic year is essential;
- d. Applicant should not have been subjected to any disciplinary action;
- e. GNLU may grant minimum one to maximum two awards of ₹ 20,000/each.The receipt of the award is subject to the recommendations of Scrutiny Committee for the current year (2019-20);
- f. The amount of and preference for scholarship will depend upon the number of applications received.



4. Terms and Conditions:

- a. Applicant must be a citizen of India;
- Recipient of the Award shall not be eligible to receive another Award for immediately succeeding one year;
- c. Recipient of the Award shall utilize the grant amount in the same financial year i.e. 2019-2020;
- d. The selected awardees will have two weeks to confirm their acceptance of the grant;
- e. In case of availability of funds due to non-utilization thereof, such fund may be awarded to the wait-listed applicants;
- f. For institutional visits, applicant must have been invited by the institution concerned;
- g. For other visits related to the participation in Conferences/Workshops/Seminars/Academies, the applicant's paper must have been accepted for presentation by the Organizing Committee of the conference or the host institution;
- h. Fund for 2019-20 will be released to the recipients upon the receipt of his/her final report;
- i. Incomplete or late applications shall be summarily rejected;
- j. All applications must be submitted through email at **gasla@gnlu.ac.in**. Any application submitted through any other means shall not be considered;
- k. Names of the successful applicants will be intimated through email;
- 1. The Grant shall cover the Awardee's international economy class airfare and visa fees. Associated costs related to meals, per diem, refreshments and accommodation are not eligible under this grant.

 Additional pages shall not be considered;
 - iv. Letter of invitation from the host institution (for academic visit);
 - v. A copy of letter of acceptance of the Paper/Presentation (oral/written) from the organizer/host institution for Conferences/Workshops/Seminars/Academies;
 - vi. Copy of Passports/PR Card of applicant.
