- The abstracts shall be screened by the editorial board. The author(s) of the shortlisted abstracts shall be intimated accordingly.
- The word limit(excluding foot notes) can range between 3000-5000 words. Mode of citation: APA (6th Edition)
- Co-authorship is permissible (subject to an upper limit of 2 author(s) per submission).
- All submissions should be the original work of the author(s) and should not have been submitted for publication/published/ presented elsewhere in any form.
- Select research papers may be published.
- Best paper awards will be conferred as per the decision of the conference panel. Certificate of Participation will be given to all the participants.
